## Pilgrimage with Spirit Catholic Radio

### 📍 Your itinerary

Participate in a live audience with **Catholic Answers Live** and hear **Christopher Check** speak on the life of **St. Junipero Serra**.

**April 12:** Our pilgrimage begins this morning as we head to San Diego, California where our Canterbury host, pilgrimage chaplain, tour director, and motor-coach driver will meet and greet us. On our way to Mission San Diego de Alcalá, known as the “Mother of the Alta California Missions”, we will enjoy lunch at the park. Later Chris Check, the President of Catholic Answers, will give a presentation on St. Junipero Serra. We will tour the Mission, celebrate Mass, and have the opportunity to participate in the Catholic Answers LIVE broadcast with host Cy Kellet at the Catholic Answers studio. We will have dinner in San Diego before heading to our hotel. Overnight Oceanside (Lunch, Dinner)

**April 13:** We set off to visit Mission San Luis Rey on the way to Mission San Juan Capistrano, named after the 14th century theologian, one of the most picturesque sites in all of California. We continue on to visit the Carmelite Sisters of the Most Sacred Heart of Los Angeles in Alhambra where the sisters will serve us lunch. Next, we visit the Mission San Gabriel Arcángel, nicknamed the “Pride of the Missions” followed by a drive to Ventura for dinner. Overnight Ventura (Breakfast, Lunch & Dinner)

**April 14:** Morning visit at the Mission San Buenaventura, named after St. Bonaventure. We then visit the Mission Santa Barbara, known as the “Queen of the Missions.” Following a break for lunch, we’ll enjoy the lovely city of Santa Barbara and afterwards, we’ll proceed to the unique city of Solvang, where the old world charm of Northern Europe meets the blue skies of Southern California. Overnight Solvang (Breakfast)

**April 15:** We depart the Santa Barbara area for San Luis Obispo. Before saying farewell to Solvang, we’ll enjoy a drive

by of the Mission Santa Ines, followed by our drive north to visit the Mission San Luis Obispo. We’ll spend leisure time in Morro Bay, the Gibraltar of the Pacific. Here, we’ll find miles of unspoiled beaches and nature trails to roam. Overnight San Luis Obispo (Breakfast & Dinner)

**April 16:** After breakfast, we’re off to Monterey to visit the Mission San Carlos Borromeo del río Carmelo, where St. Junipero Serra is entombed beneath the sanctuary of this mission church. We’ll view his sarcophagus as well as that of three of his fellow missionaries. This afternoon we will enjoy the beautiful 17-Mile Drive which takes us through coastline and the Pebble Beach Resort. This evening we will have leisure time for dinner down at the Cannery row in Monterey. Overnight Monterey (Breakfast & Dinner)

**April 17:** This morning we travel north to visit the Mission Santa Cruz, an active participant in the Parish of St. Joseph. We break for lunch, then proceed to visit the Mission San Francisco de Asís. We cap the day with some leisure time for dinner in the Pier 39 area of San Francisco. Overnight San Francisco (Breakfast & Dinner)

**April 18:** Our visit will continue into the famed Sonoma Wine Region and Marin County area, where we’ll have the opportunity to visit Cline Cellars, a family-owned Napa winery located on the original Sonoma Mission site. After our visit, we’ll find the last of the originally established California Missions: the Mission San Francisco Solano, nestled in the wine country 40 miles north of San Francisco and across from the site of the Bear Flag Revolt of 1846. Our farewell dinner will follow this evening. Overnight San Francisco area (Breakfast & Dinner)

**April 19:** With a renewed sense of pilgrimage and an invigorated love of our Catholic faith, we bid farewell to our fellow pilgrims and return home on our own. (Breakfast)

**Itineraries:** Itineraries are prepared and scheduled in advance according to the best information available at the time and are subject to change by the date of the pilgrimage.

**Pricing:** Canterbury Pilgrimages & Tours Inc. reserves the right to adjust pricing should the following occur; (1) Rise in Airfare due to higher fuel costs, etc. (2) Rise in ground costs due to increases in hotel charges, bus fares, fees, taxes and other costs due to the fluctuating value of the U.S. dollar against foreign currency.

**Deposits and final Payments:** A deposit of \$450 per person is required to hold your reservation of which \$200 is non-refundable (may be refundable under travel insurance conditions). Final payment is due 75 days prior to the departure date. Payment can be made by credit card or check. Credit card payments are subject to a 3% processing fee. Call (800) 653-0017 to make a credit card payment.

**Cancellation fees:** If cancellation in writing is received by Canterbury Pilgrimages & Tours Inc. more than 75 days prior to departure all payments made toward the price of the tour will be refunded, less a \$200 processing fee. For cancellations received less than 75 days prior to departure, the initial deposit of \$450 plus any applicable charges imposed by the airlines, hotels, and bus companies on Canterbury Pilgrimages & Tours will be non-refundable. Please note that the amount may vary with each pilgrimage and the vendors we work with. Canterbury Pilgrimages & Tours Inc. retains the right to cancel any pilgrimage up to the departure date in which case all funds received will be returned within 10 business days.

**Baggage:** Please follow the general rule of traveling light - If you cannot carry it do not bring it. Passengers are permitted one piece of luggage per person. Baggage handling is included for one suitcase per person only, whenever possible, in the cost of the pilgrimage. The airlines for international flights will not allow a suitcase exceeding 50 pounds (subject to change), if over 50lbs., the fees can be costly. On inter-European flights, which are not directly connected to a transatlantic flight the baggage weight limit is lower. We will provide you with this information in the final travel documents. Baggage handling is not available on any of the trains. Every effort will be made to handle luggage carefully, however Canterbury Pilgrimages & Tours Inc. will not assume any liability for lost or damaged luggage or items inside luggage carrier. (Travel insurance may apply)

**Travel insurance:** We strongly recommend the purchase of travel insurance (personal accident/trip cancellation/baggage insurance).
