Sunday, July 2: Depart from Reno to Mexico City Dinner and overnight in Mexico City.

Monday, July 3: Pick up at the Hotel and transfer to the Shrine of Our Lady of Guadalupe beginning with Mass at the Basilica. After Mass we will have time for a tour of the shrine including the Museum, Tepeyac Hill, Capilla del Cerrito, Tepeyac Garden, and the Chapel of the Indians. There will also be time for personal devotions. Dinner and overnight in Mexico City.

Tuesday, July 4: After breakfast we will head to City to Tlatelolco, to visit the Three Culture Square, where is located the XVI Century Parish of Santiago Tlatelolco first catholic church of the New Continent that still exist dedicated to St. James, to honor the patron saint of the Spanish. Then to the TEOTIHUACAN, UNESCO World Heritage Archaeological zone, exploring the ruins of the Pyramids of the Sun and the Moon and the Aztec Temple of Tlaloc and Quetzalcoatl. On the way back to the hotel stop at Acolman Augustinian Ex Convent and church, for a tour at the monastery. Dinner and overnight in Mexico City.

Wednesday, July 5: Following breakfast, leave Mexico City for a spectacular ride through the mountains to

Tlaxcala to Ocotlan, "place of the burning oak", where in 1531, the Blessed Virgin appeared to Juan Diego Bernadino. The Blessed Virgin Mary burned an image of her perfections into the trunk of an old oak tree. Also visit The Franciscan convent of Our Lady of Assumption, today the Cathedral of Tlaxcala. After lunch in Tlaxcala we continue on to Puebla where we will enjoy a tour that includes the Cathedral of Puebla and the magnificent Chapel of Our Lady of the Rosary, with its most famous scalloped gold leaf walls and ceilings, St. Dominic's Church. Overnight in Puebla.

Thursday, July 6: Mexico City Historical Center beginning with Mass at the Mexico's Cathedral (Catedral Metropolitana) the oldest and largest cathedral in all of Latin America. Continue the visit at the Government Mexican Palace, then the visit to the Ancient City of the Mexicas and in the Historical Center. visit the Aztec Exhibition room at the Anthropology Museum. Then the tour continues to Xochimilco, to the Floating Gardens of Xochimilco. Dinner and overnight in Mexico City.

Saturday July 7: After breakfast, check out, van or coach brings us to the Shrine of the Lady of Guadalupe for our farewell and then we will depart to the airport of Mexico City to fly back to Reno, Nevada USA.

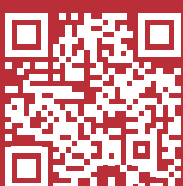

Terms of Service

Itineraries: Itineraries are prepared and scheduled in advance according to the best information available at the time and are subject to change by the date of the pilgrimage.

Pricing: Canterbury Pilgrimages & Tours Inc. reserves the right to adjust pricing should the following occur; (1) Rise in Airfare due to higher fuel costs, etc. (2) Rise in ground costs due to increases in hotel charges, bus fares, fees, taxes and other costs due to the fluctuating value of the U.S. dollar against foreign currency.

Deposits and Payments: A deposit of \$450 per person is required to hold your reservation of which \$200 is non-refundable (may be refundable under travel insurance conditions). Payment can be made by credit card or check. Call (800) 653-0017 to make a credit card payment.

Final payments: Final payment is due 75 days prior to the original departure date except in the case of postponement. The original departure date is a date of departure for which a new reservation is intended. In the event of postponement, if the decision of postponement is made sooner than 75 days prior to the original departure date, final payment will be due 75 days prior to the new departure date. If the decision of postponement is made 75 days prior to the original departure date or later then the payment remains due 75 days prior to the original departure date.

Cancellation fees: If the traveler's written notice of cancellation is received by Canterbury Pilgrimages & Tours Inc. more than 75 days prior to the original departure date all payments made toward the price of the tour will be refunded, less a \$200 processing fee. For cancellations received 75 days or less prior to the trip; departure, the initial deposit of \$450 plus any applicable charges imposed by the airlines, hotels, and bus companies on Canterbury Pilgrimages & Tours will be non-refundable. Please note that the amount may vary with each pilgrimage and the vendors we work with. In the event of postponement, the above still applies. Canterbury Pilgrimages & Tours Inc. retains the right to cancel any pilgrimage up to the departure date in which case all funds received will be returned within 10 business days.

Baggage: Please follow the general rule of traveling light - If you cannot carry it do not bring it. Passengers are permitted one piece of luggage per person. Baggage handling is included for one suitcase per person only, whenever possible, in the cost of the pilgrimage. The airlines for international flights will not allow a suitcase exceeding 50 pounds (subject to change), if over 50lbs., the fees can be costly. On inter-European flights, which are not directly connected to a transatlantic flight the baggage weight limit is lower. We will provide you with this information in the final travel documents. Baggage handling is not available on any of the trains. Every effort will be made to handle luggage carefully, however Canterbury Pilgrimages & Tours Inc. will not assume any liability for lost or damaged luggage or items inside luggage carrier. (Travel insurance may apply)

Travel insurance: We strongly recommend the purchase of travel insurance (personal accident/illness/injury/trip cancellation/baggage insurance). Canterbury Pilgrimages & Tours Inc. disclaims responsibility for accidents, personal illness or injury, trip cancellations, or handling of baggage not under our control. All categories of insurance may be purchased from Canterbury as provided by Allianz Travel Insurance.

Not Included: Gratuities, room service, laundry, telephone calls, and all personal expenses.

CPT will not be responsible for any loss incurred by traveler, including lost days of the scheduled tour, due to a cancelled flight or other means and modes of transportation. Please investigate purchasing travel insurance as recommended, to cover any type of loss associated with cancelled air or other transportation.
