Day 1: Nov. 3, 2025 | Our Pilgrimage Begins

Our pilgrimage begins with an overnight flight from Kansas City (MCI) to Lisbon (LIS).

Day 2: Nov. 4, 2025 | Arrival in Lisbon

Upon arrival in Lisbon, we'll visit the birthplace of St. Anthony of Padua in Lisbon and further north we'll visit St. Stephen's Church in Santarem and adore the miracle of the "Bleeding Host." Afternoon arrival into Fátima. Tonight, we'll all head to the shrine for the candlelight procession. Dinner. Overnight Fátima.

Day 3: Nov. 5, 2025 | Capelinha, Aljustrel, Valinho

We enjoy Mass this morning at the Capelinha built over the holm oak tree where Our Lady appeared five times to the three shepherd children Lucia, Jacinta, and Francisco. We'll tour the basilica and shrine. This afternoon, we'll visit Aljustrel where the angel of Portugal appeared, and Valinhos where Our Lady appeared in August of 1917. Tonight, we'll all head to the shrine for the candlelight procession. Dinner. Overnight Fátima.

Day 4: Nov. 6, 2025 | Madrid

Today we depart for Madrid, upon arrival we'll enjoy lunch and then we will have a tour of the beautiful capital of Spain. We'll visit the Cathedral of Saint Mary the Royal and celebrate mass. Dinner. Overnight Madrid.

Day 5: Nov. 7, 2025 | Zaragoza, Basilica del Pilar, Cathedral of Zaragoza

After breakfast, we continue onto Zaragoza. On arrival we'll visit the magnificent Basilica del Pilar, built upon the site of where Our Lady appeared to St. James. Next, we continue to the Cathedral of Zaragoza formally known as the church of San Vicente. Overnight Zaragoza.

Day 6: Nov. 8, 2025 | Journey to Lourdes

Finally, we'll cross the border to France on our way to Lourdes. Upon arrival we will visit Bartrès and the pilgrim's

Day 7: Nov. 9, 2025 | Our Lady of Lourdes, Cave of Apparitions, Basilica of St. Bernadette

Today we visit the Sanctuary of Our Lady of Lourdes, the Cave of Apparitions, the Basilicas and the House of St. Bernadette. In the afternoon we'll have free time to participate in the ceremonies of the Sanctuary and bathe in the miraculous waters. After dinner, we participate in the Candlelight Rosary Procession. Overnight Lourdes.

Day 8: Nov. 10, 2025 | Benedictine Monastery of Montserrat, Barcelona

Following breakfast, we travel to the Benedictine monastery of Montserrat. Here, we visit the basilica dedicated to Our Lady of Montserrat. Following our visit we continue to Barcelona. Overnight Barcelona.

Day 9: Nov. 11, 2025 | Barcelona, Antoni Gaudi's, Sagrada Família

We will spend the day in Barcelona, where we'll have a guided tour of this beautiful city, including a visit to Antoni Gaudi's breathtaking Sagrada Família. Dinner. Overnight Barcelona.

Day 10: Nov. 12, 2025 | Return Home

Terms of Service

Itineraries: Itineraries are prepared and scheduled in advance according to the best information available at the time and are subject to change by the date of the pilgrimage.

Pricing: Canterbury Pilgrimages & Tours Inc. reserves the right to adjust pricing should the following occur; (1) Rise in Airfare due to higher fuel costs, etc. (2) Rise in ground costs due to increases in hotel charges, bus fares, fees, taxes and other costs due to the fluctuating value of the U.S. dollar against foreign currency.

Deposits and Payments: A deposit of \$450 per person is required to hold your reservation of which \$200 is nonrefundable (may be refundable under travel insurance conditions). Payment can be made by credit card or check. Call (800) 653-0017 to make a credit card payment.

Final payments: Final payment is due 90 days prior to the original departure date except in the case of postponement. The original departure date is a date of departure for which a new reservation is intended. In the event of postponement, if the decision of postponement is made sooner than 90 days prior to the original departure date, final payment will be due 90 days prior to the new departure date. If the decision of postponement is made 90 days prior to the original departure date or later then the payment remains due 90 days prior to the original departure date.

Cancellation fees: If the traveler's written notice of cancellation is received by Canterbury Pilgrimages & Tours Inc. more than 90 days prior to the original departure date all payments made toward the price of the tour will be refunded, less a \$200 processing fee. For cancellations received 90 days or less prior to the trip, departure, the initial deposit of \$450 plus any applicable charges imposed by the airlines, hotels, and bus companies on Canterbury Pilgrimages & Tours will be non-refundable. Please note that the amount may vary with each pilgrimage and the vendors we work with. In the event of postponement, the above still applies. Canterbury Pilgrimages & Tours Inc. retains the right to cancel any pilgrimage up to the departure date in which case all funds received will be returned within 10 business days.

Baggage: Please follow the general rule of traveling light - If you cannot carry it do not bring it. Passengers are permitted one piece of luggage per person. Baggage handling is included for one suitcase per person only, whenever possible, in the cost of the pilgrimage. The airlines for international flights will not allow a suitcase exceeding 50 pounds (subject to change), if over 50lbs., the fees can be costly. On inter-European flights, which are not directly connected to a transatlantic flight the baggage weight limit is lower. We will provide you with this information in the final travel documents. Baggage handling is not available on any of the trains. Every effort will be made to handle luggage carefully, however Canterbury Pilgrimages & Tours Inc. will not assume any liability for lost or damaged luggage or items inside luggage carrier. (Travel insurance may apply)

Travel insurance: We strongly recommend the purchase of travel insurance (personal accident/illness/injury/trip cancellation/baggage insurance). Canterbury Pilgrimages & Tours Inc. disclaims responsibility for accidents, personal illness or injury, trip cancellations, or handling of baggage not under our control. All categories of insurance may be purchased from Canterbury as provided by Allianz Travel Insurance.

CP will not be responsible for any loss incurred by traveler, including lost days of the scheduled tour, due to a cancelled flight or other means and modes of transportation. Please investigate purchasing travel insurance as recommended, to cover any type of loss associated with cancelled air or other transportation. All travel involves risk of loss, injury and death.
